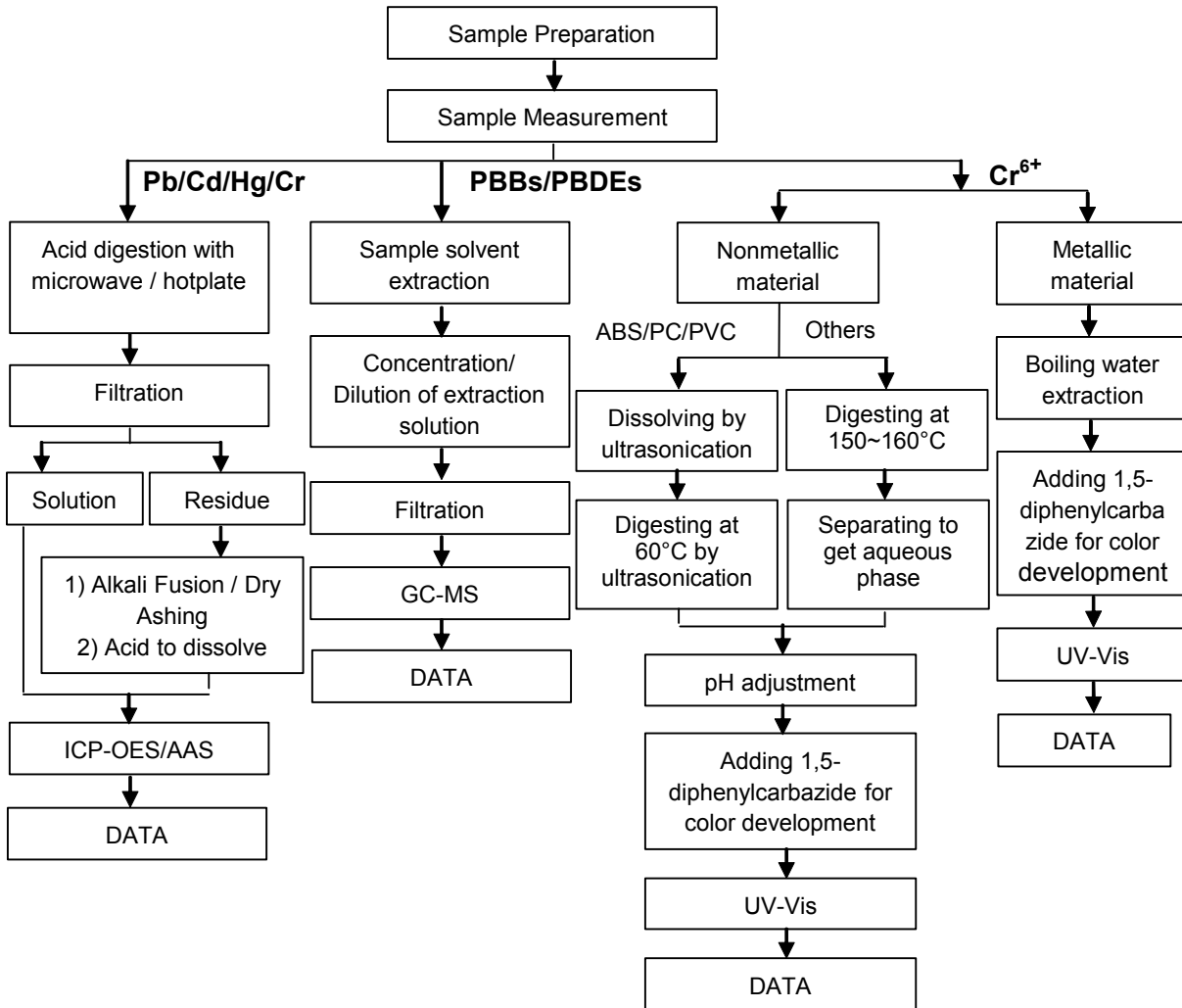

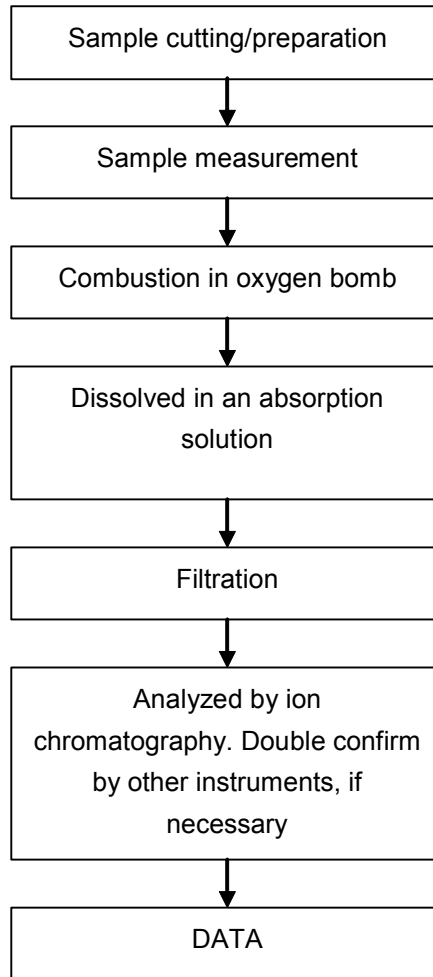

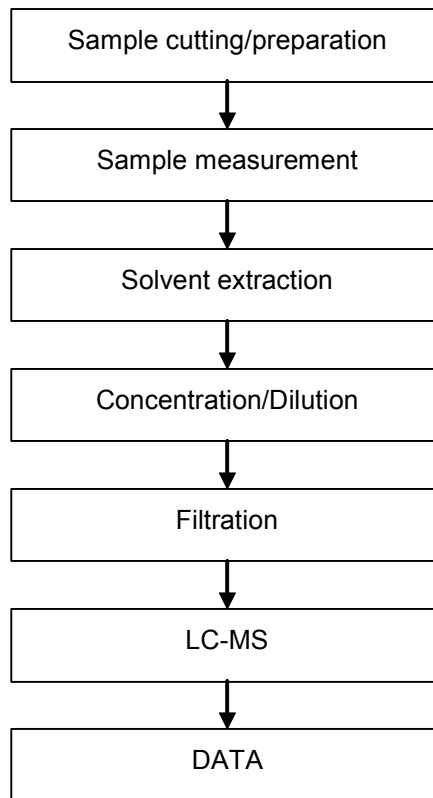

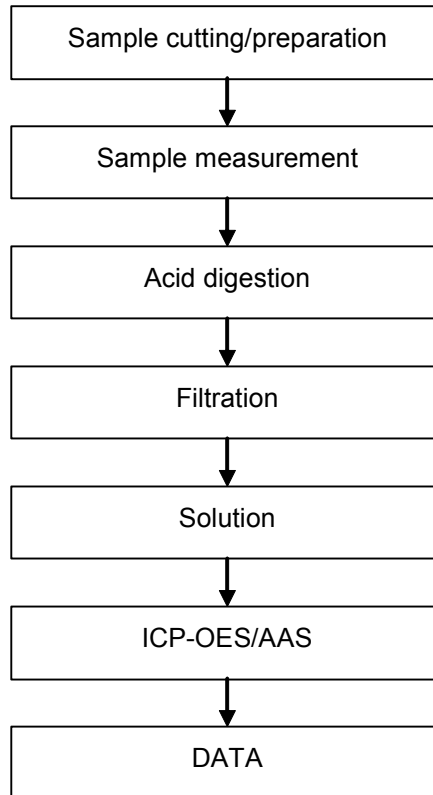

Elements Testing Flow Chart

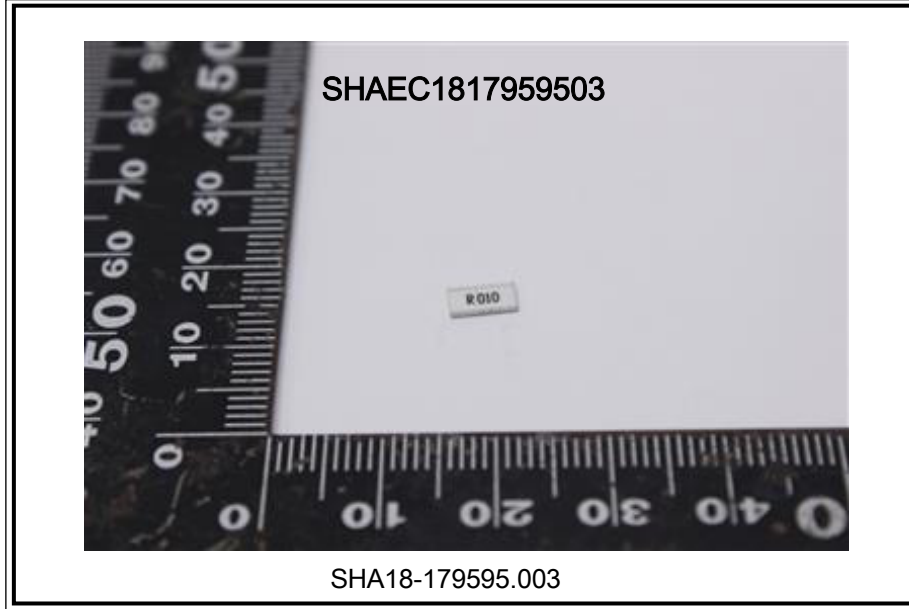
