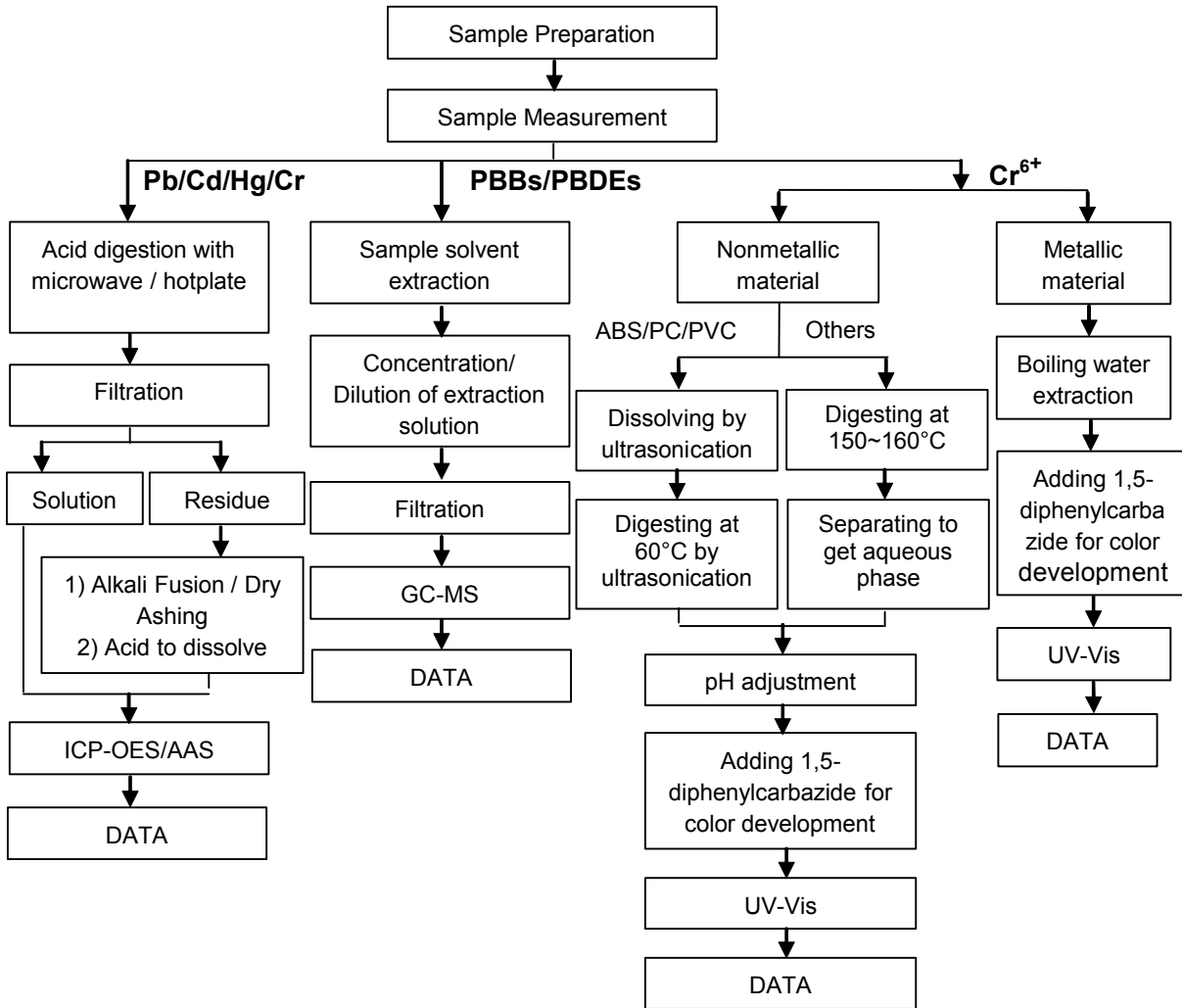

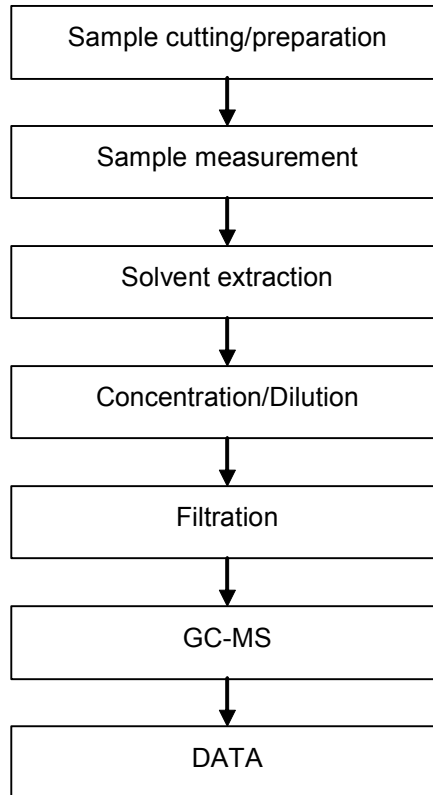

Phthalates Testing Flow Chart

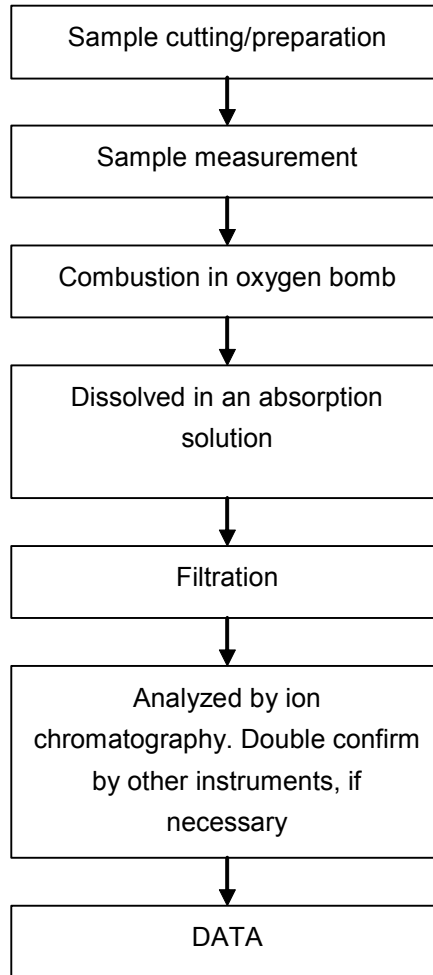

Halogen Testing (oxygen bomb) Flow Chart

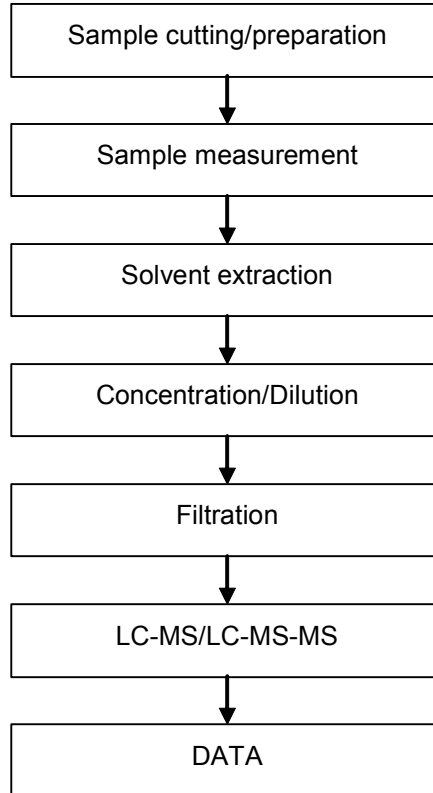

PFOS/PFOA Testing Flow Chart

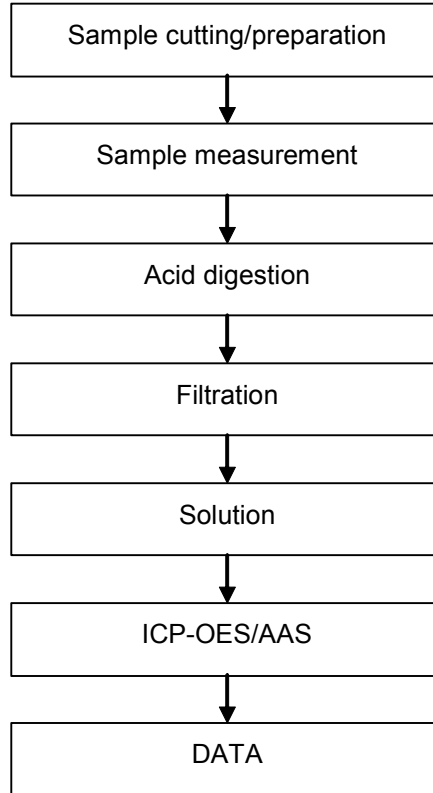

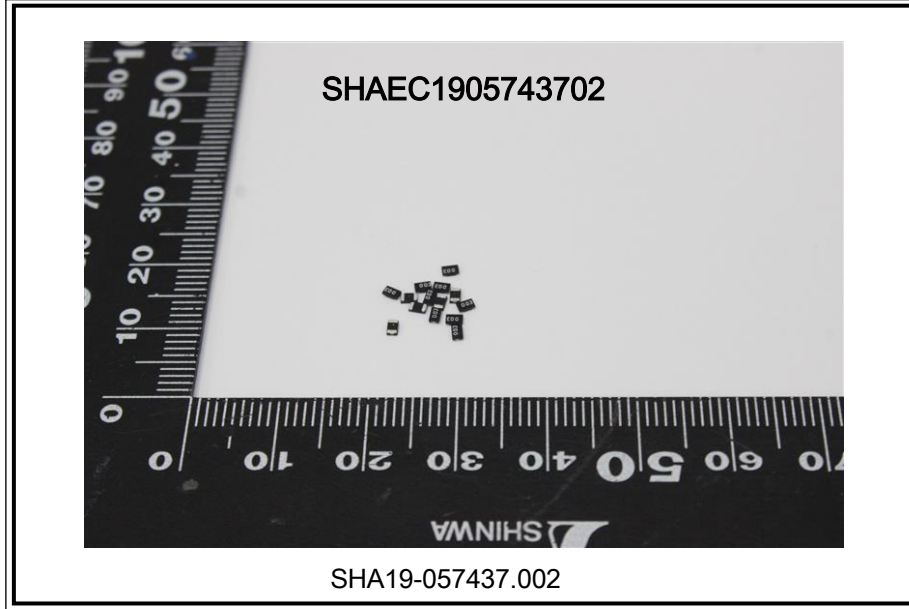
Elements Testing Flow Chart
