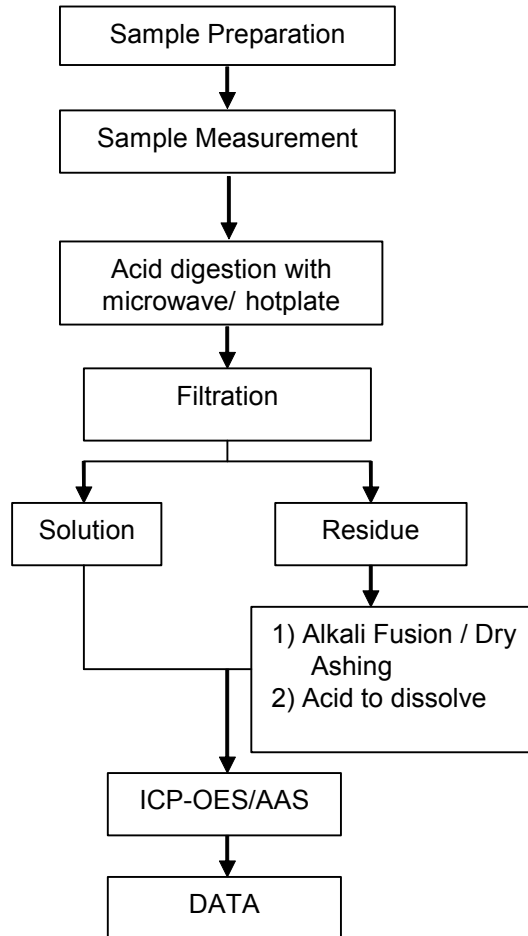

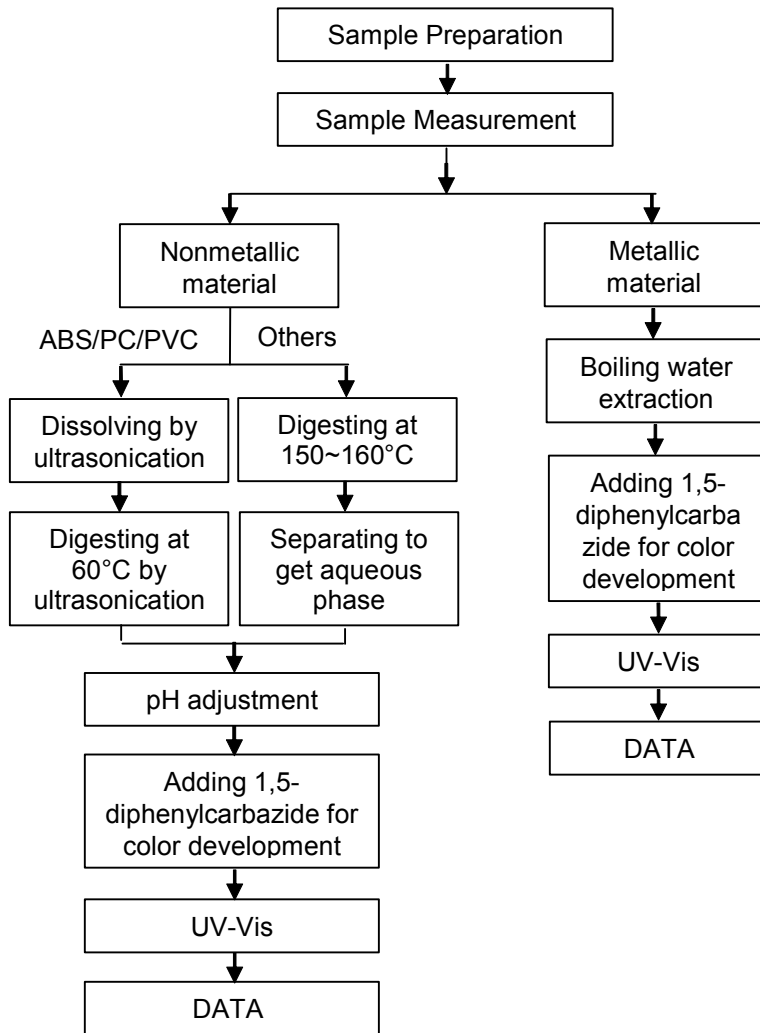

Hexavalent Chromium (Cr(VI)) Testing Flow Chart

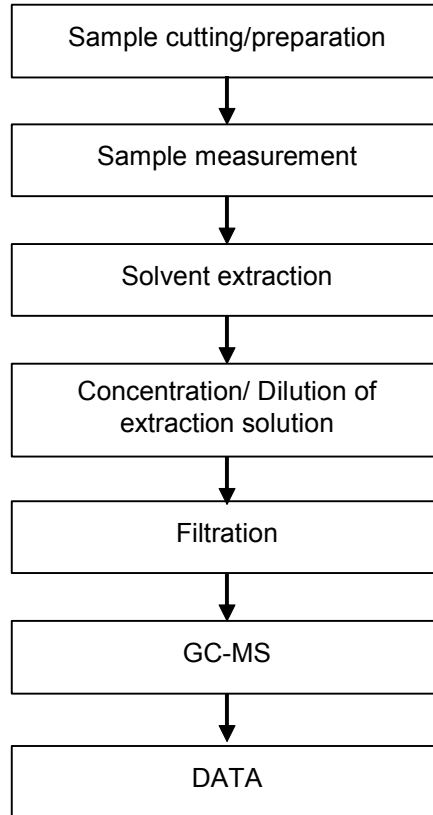

### PBBs/PBDEs Testing Flow Chart

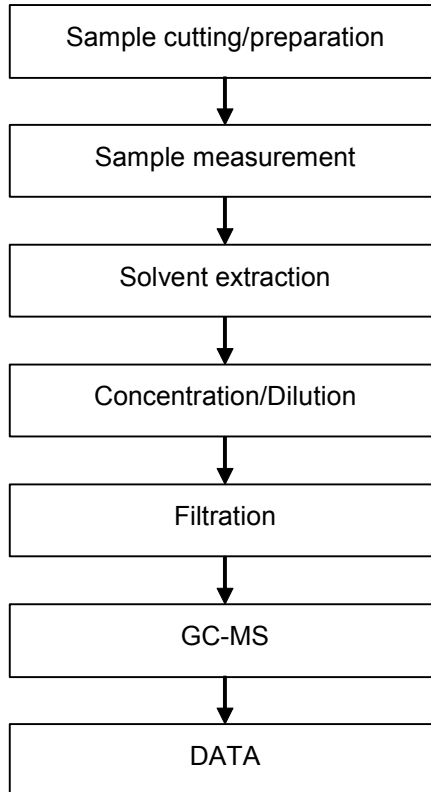

Phthalates Testing Flow Chart



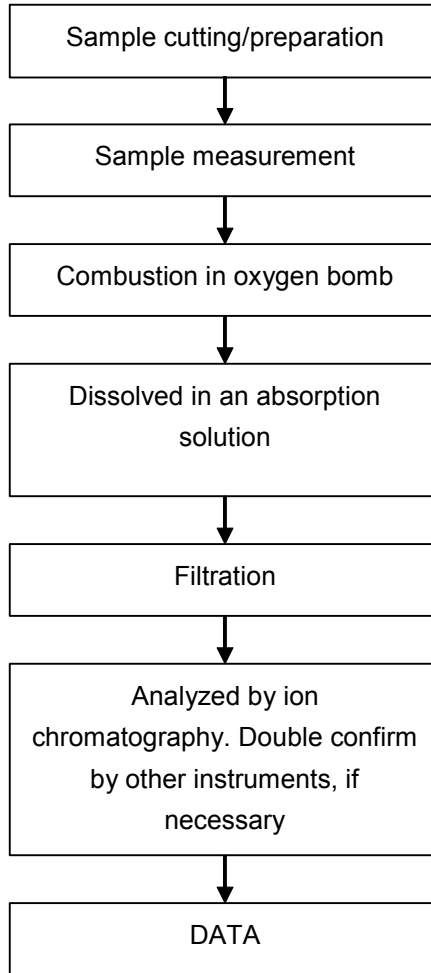

### Halogen Testing (oxygen bomb) Flow Chart

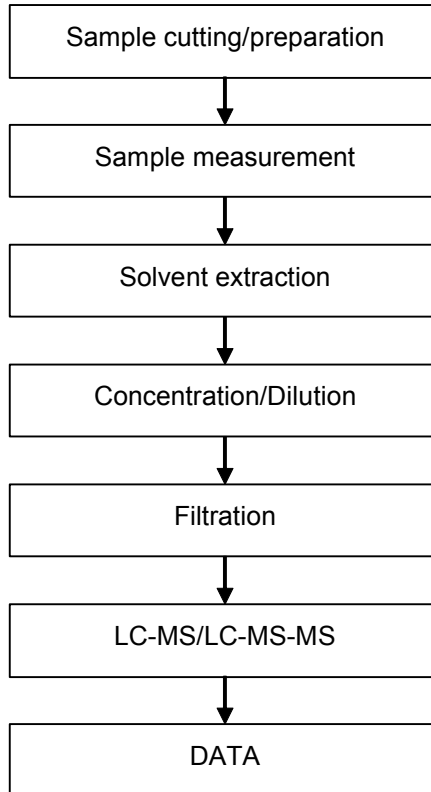

### PFASs/ PFOS/PFOA Testing Flow Chart

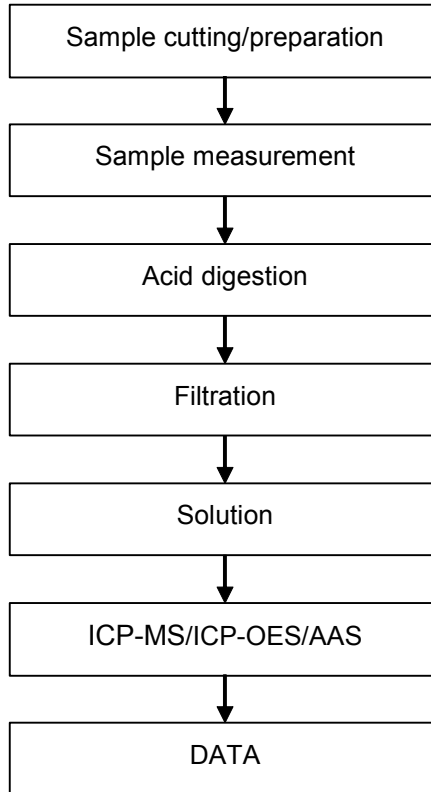
