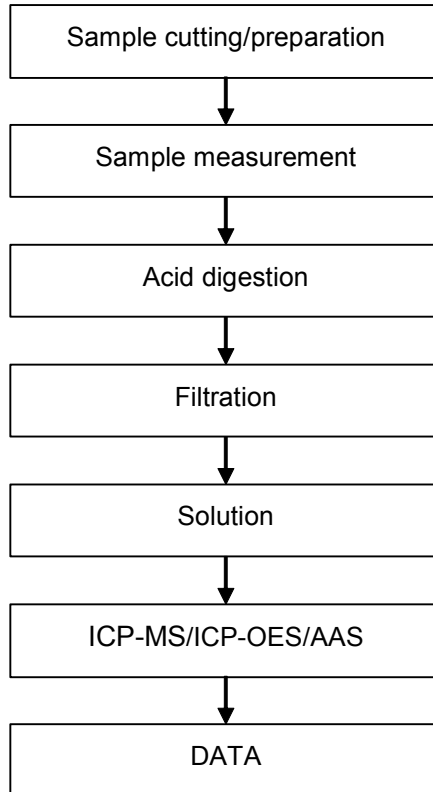

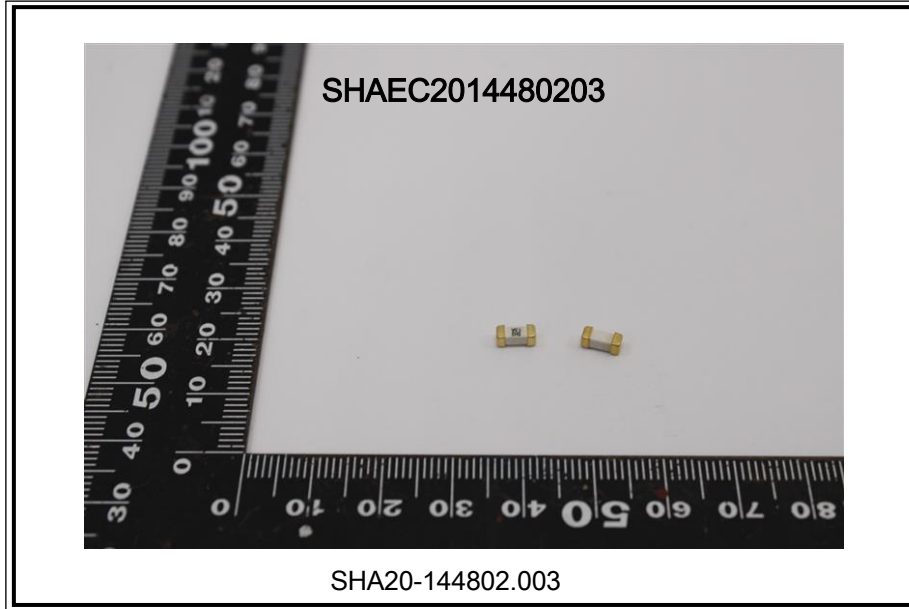
### Elements Testing Flow Chart
