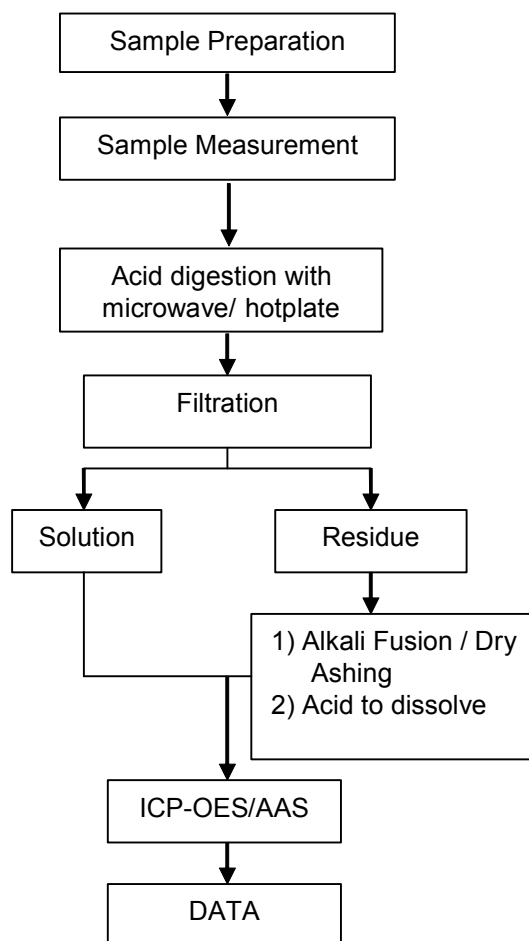

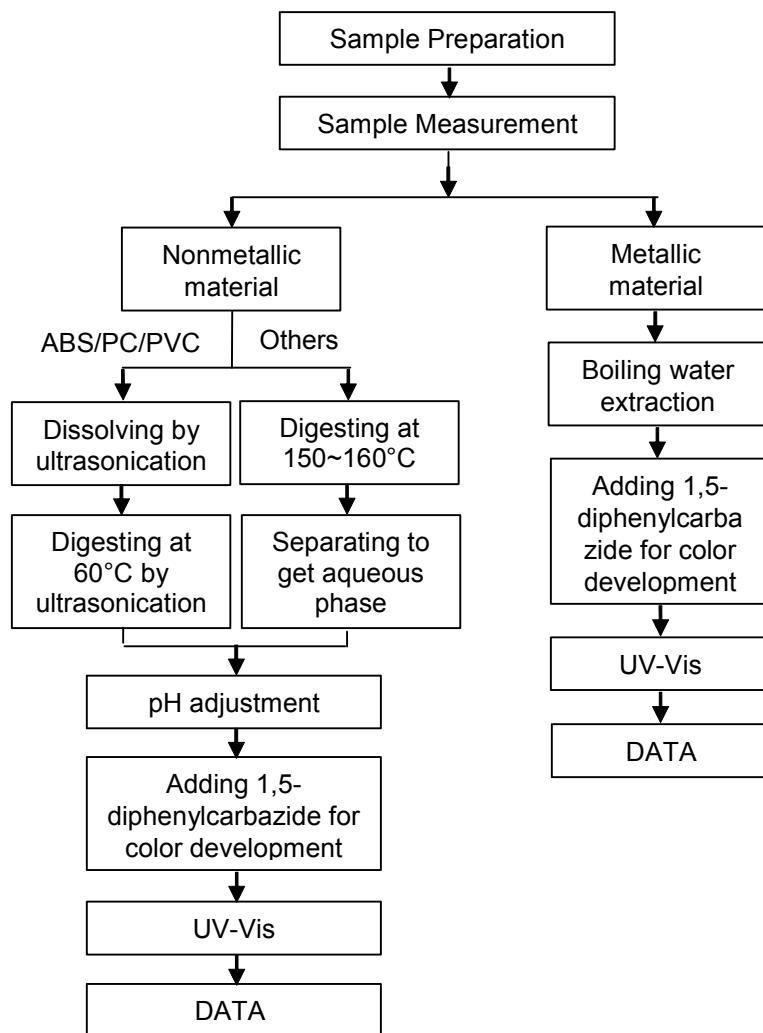

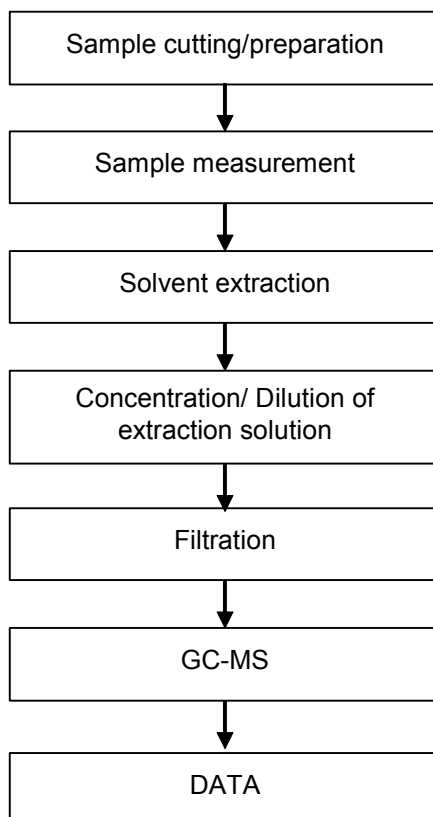

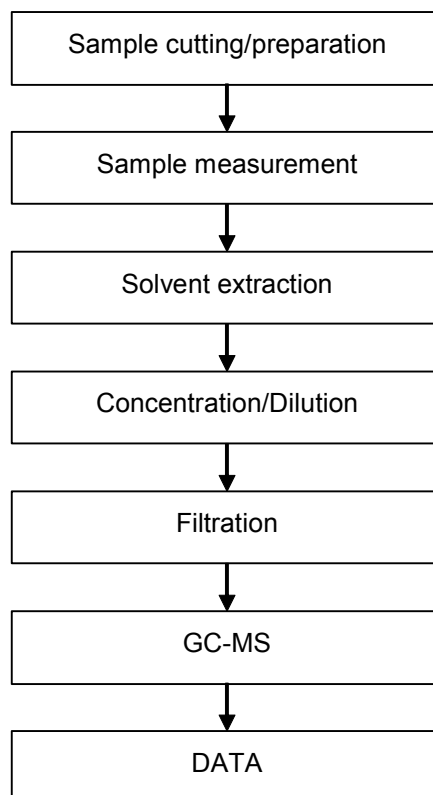

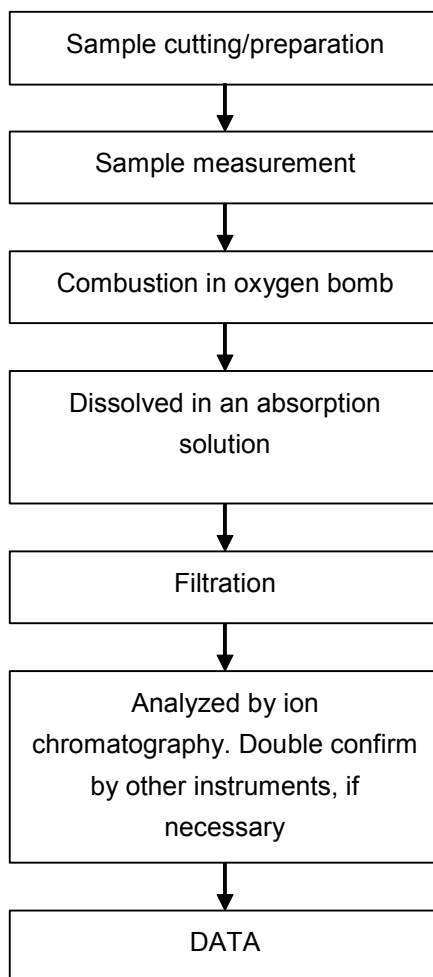

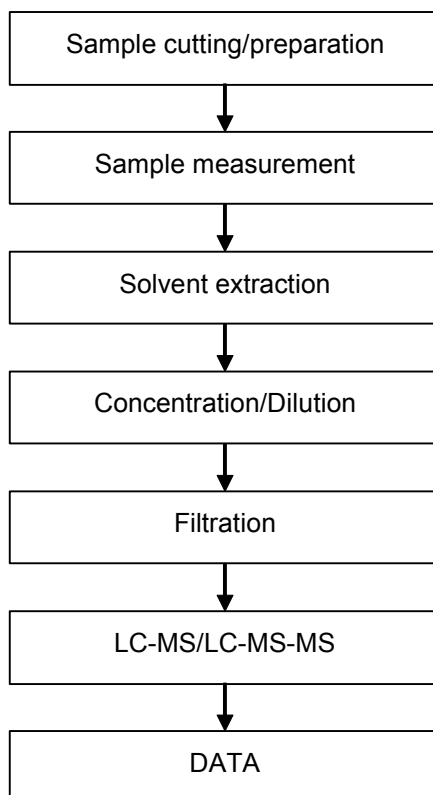

PFASs/ PFOS/PFOA Testing Flow Chart

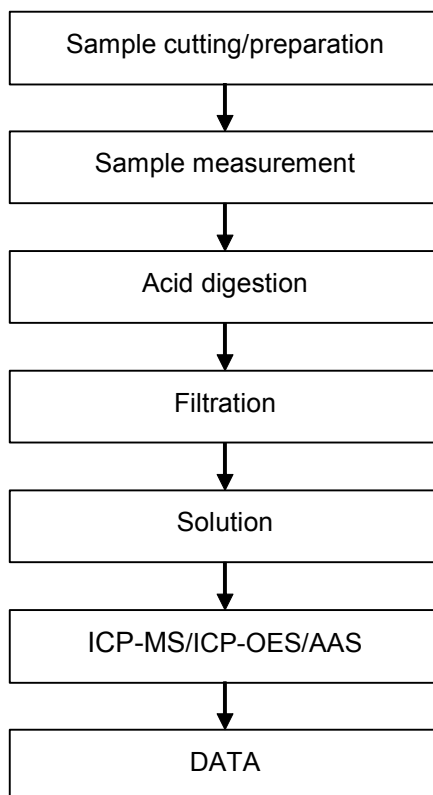
