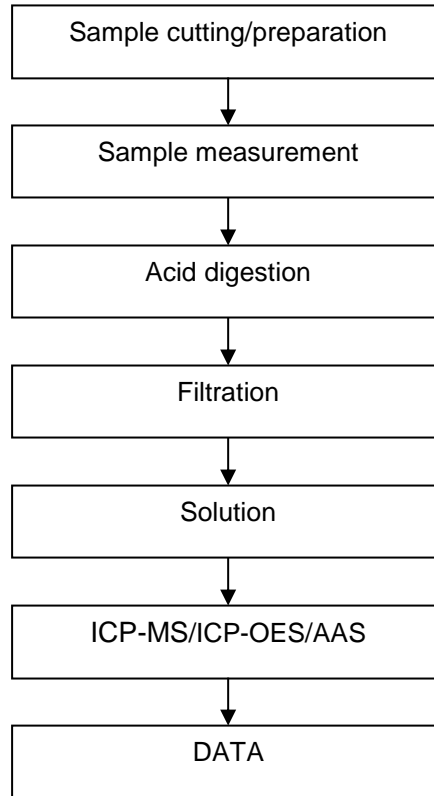

### Elements Testing Flow Chart

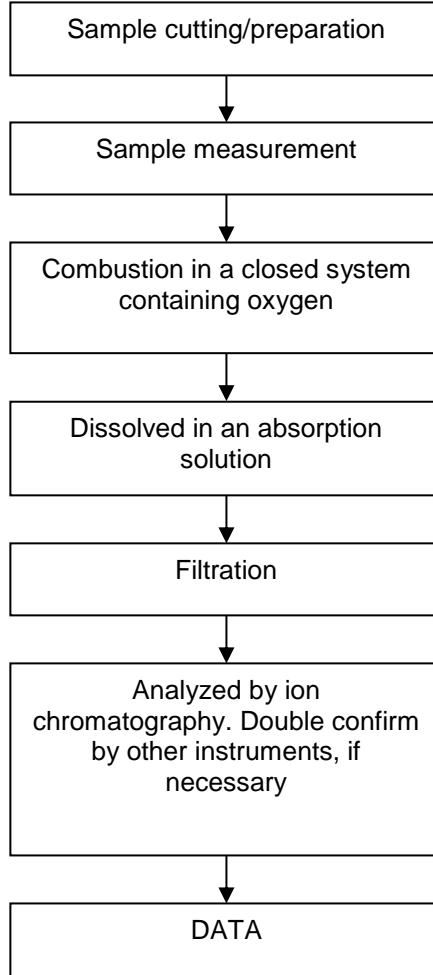

**Halogen Testing Flow Chart**



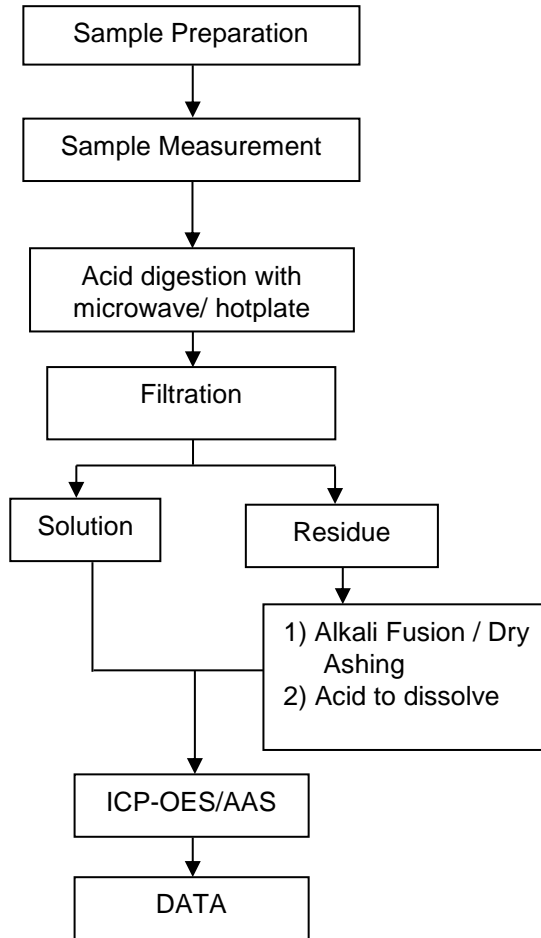

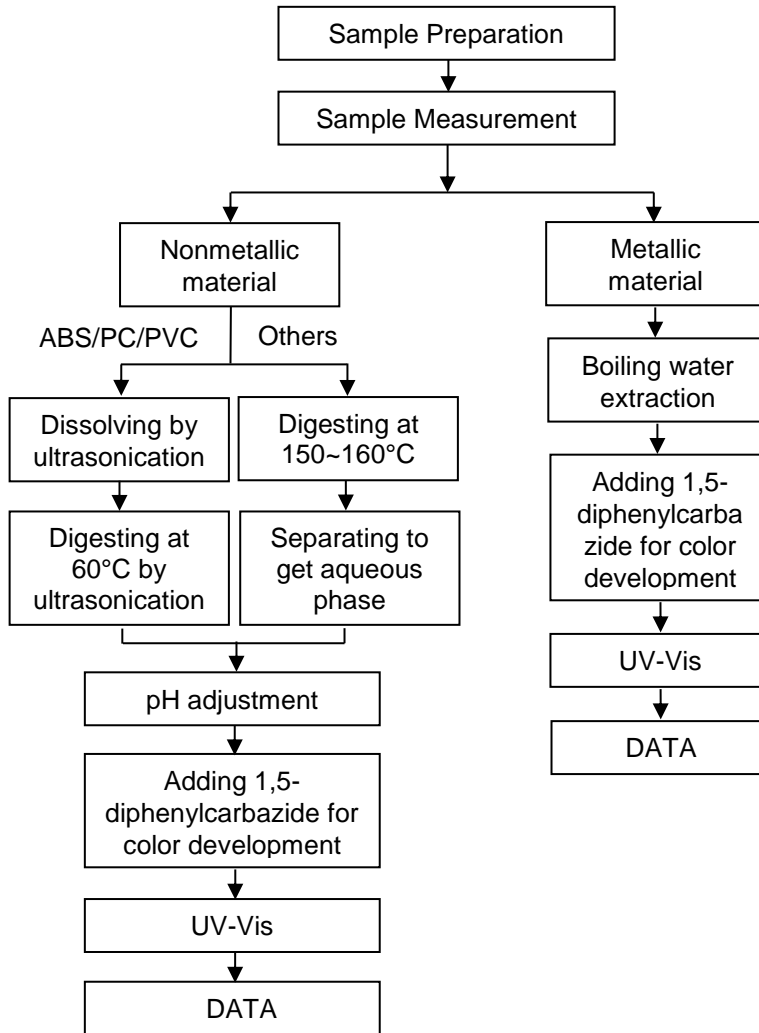

**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**

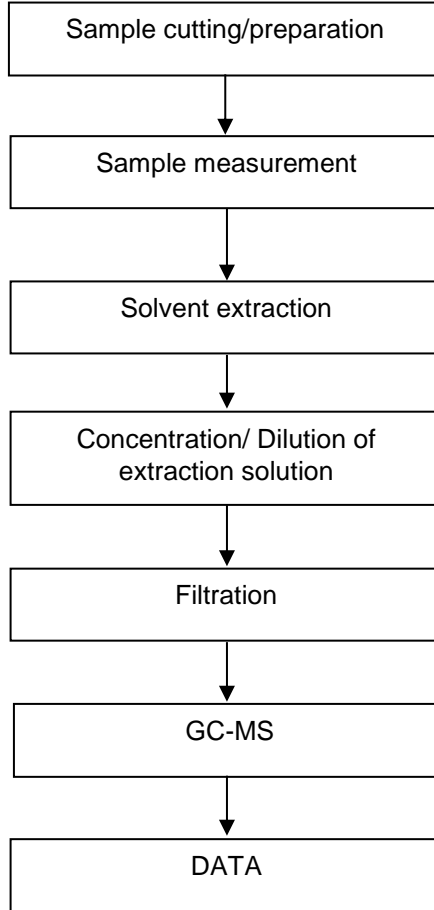

**PBBs/PBDEs Testing Flow Chart**



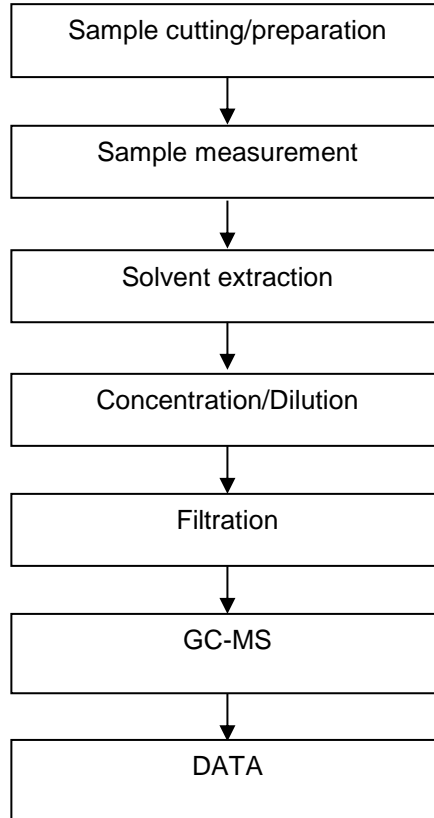

### Phthalates Testing Flow Chart



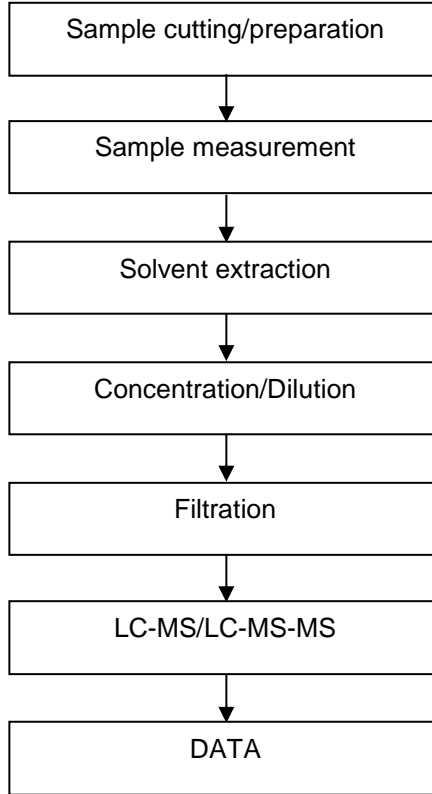
