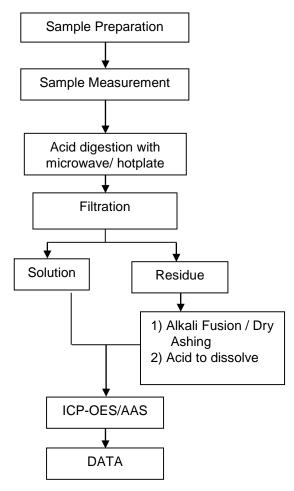



### Hexavalent Chromium (Cr(VI)) Testing Flow Chart





### **PBBs/PBDEs Testing Flow Chart**





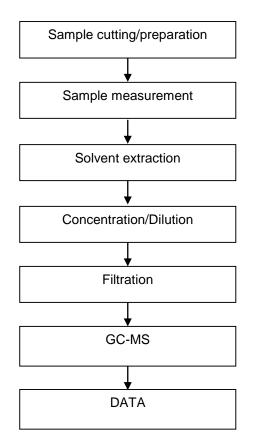

### **Phthalates Testing Flow Chart**





### **Elements Testing Flow Chart**







### Halogen Testing Flow Chart




