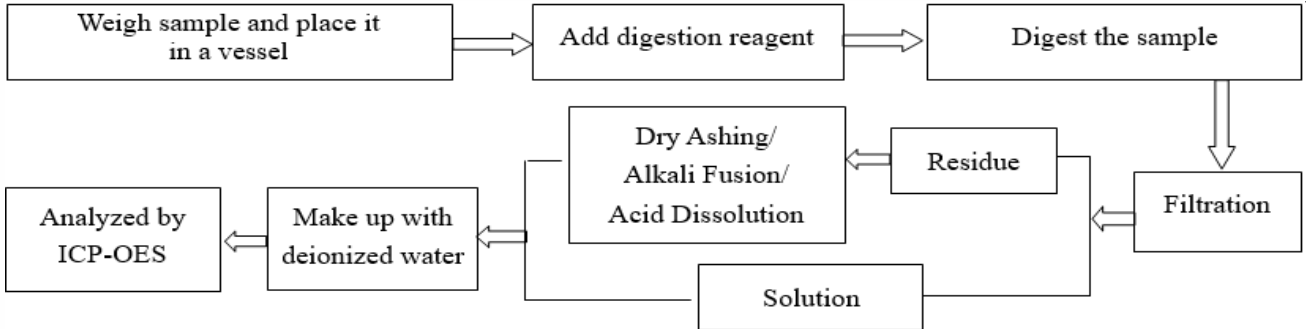

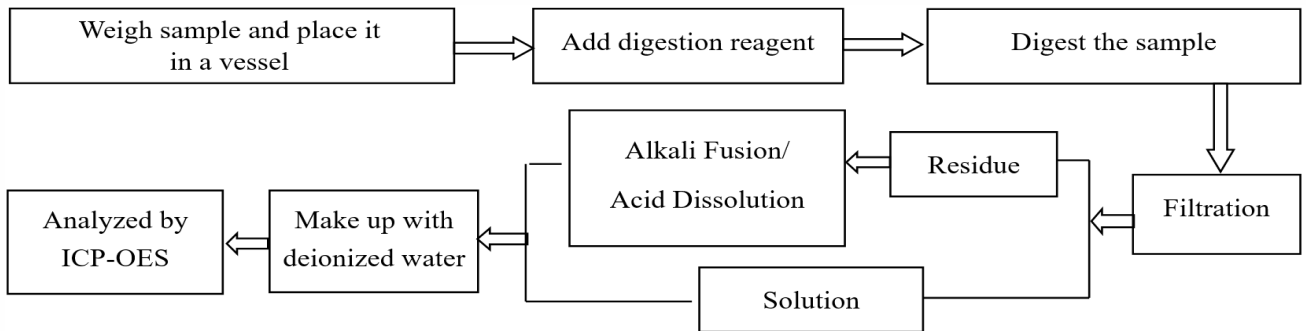

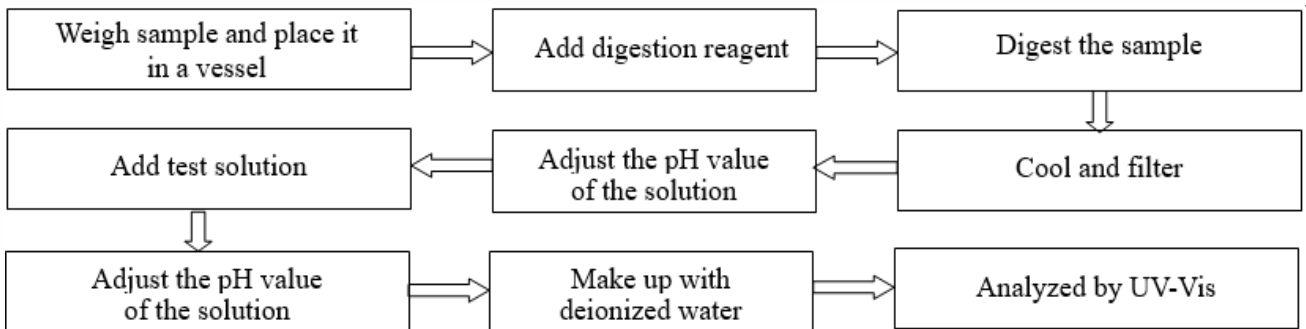
1. Lead (Pb), Cadmium (Cd), Chromium (Cr)



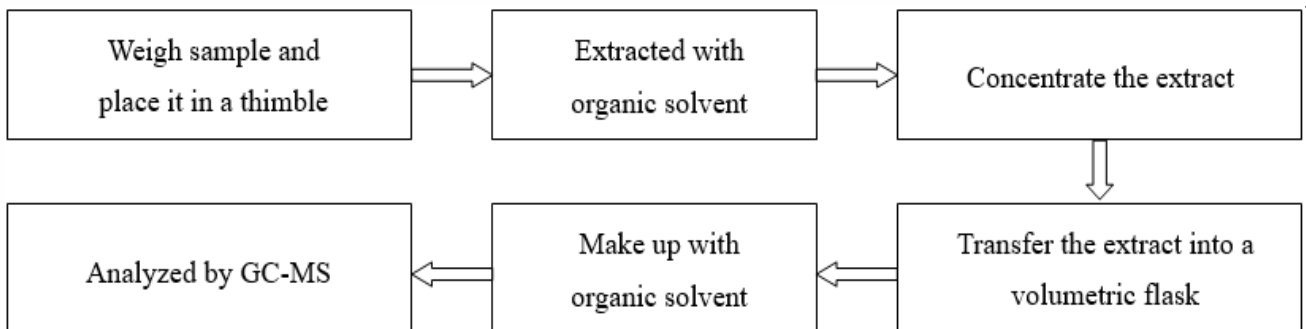
2. Mercury (Hg)

4. Polybrominated Biphenyls (PBBs), Polybrominated Diphenyl Ethers (PBDEs)

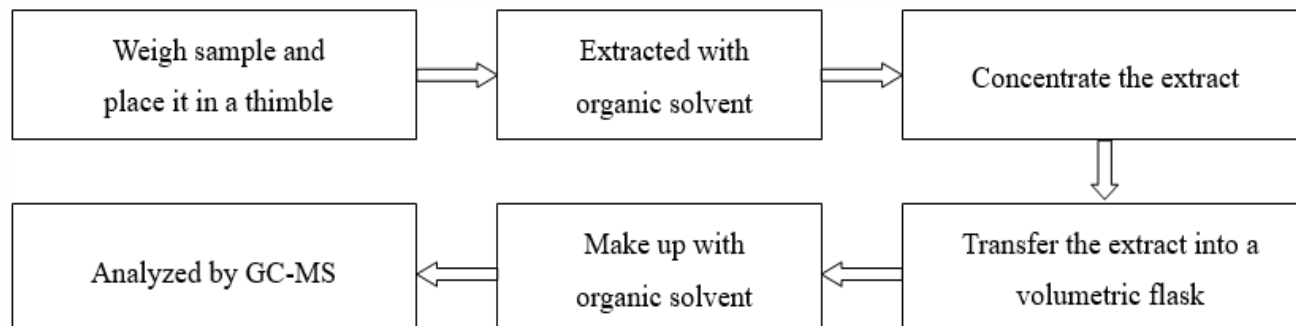

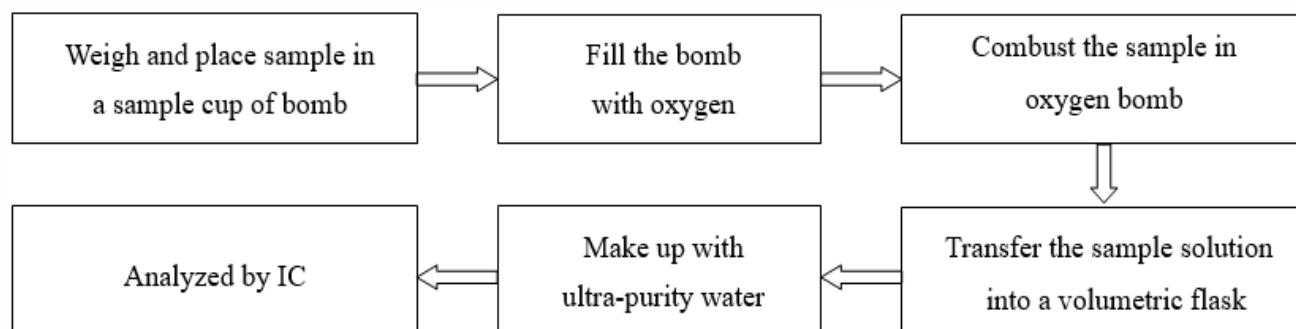

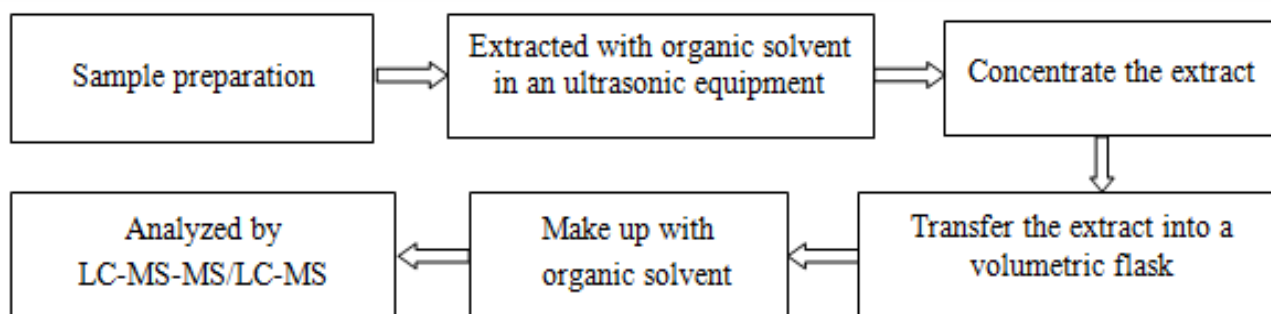

7. Perfluorooctanoic Acid(PFOA), Perfluorooctane Sulfonates(PFOS)

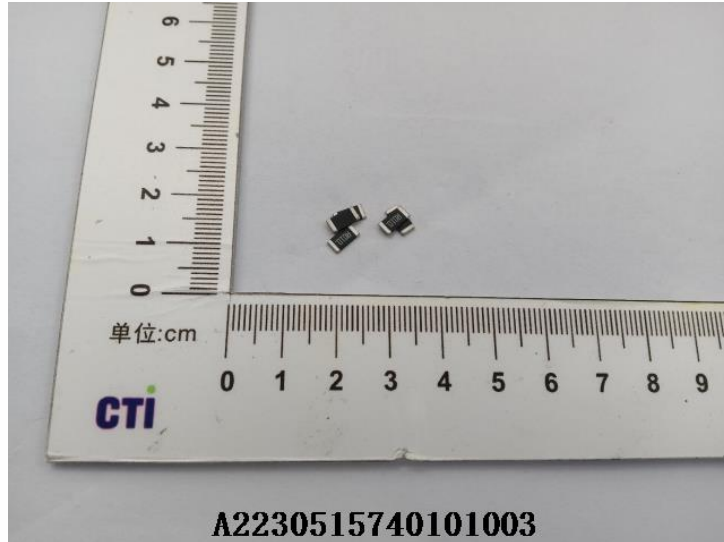
